### YOU ARE INVITED TO PARTICIPATE IN THE ANNUAL NORTH CAROLINA POTATO FESTIVAL

This is a family outside festival in downtown Elizabeth City, NC. A limited number of food vendors will be allowed to display and/or sell their goods. No vendor will have exclusive rights to this show. All vendor set-ups must be professional in appearance (you are required to have a tent or a trailer) and will be monitored throughout the event. No bull horns or PA systems allowed.

**CRITERIA:** Set-up time is: Friday, May 20<sup>th</sup> from 1:00 pm until 4:30 pm. Vendors must pass inspection by the Pasquotank County Health Department (Health Department Application can be downloaded from our website). **You will need to include a separate check (\$75.00) made Payable to the Pasquotank County Health Department for inspection fees.** Non-Profits must supply proof of Non-Profit status with application. Vendors must submit a complete list of every food item they want to sell. Please include a color picture (non-returnable) of your unit.

The Festival has the exclusive rights to **ALL SOFT DRINK AND BOTTLED WATER**. You may sell fruit drinks.

### VENDORS FEES ARE NONREFUNDABLE (UPON ACCEPTANCE).

**Fees: Non-Profit: \$150.00 FOR 10 FEET COMMERCIAL: \$325 FOR 10 FEET / \$575 FOR 20 FEET / \$700 FOR 30 FEET**

Spaces are 10'L x 10"W; Additional space can be purchased. Your concessions cannot encroach on other vendors in adjacent spaces. Remember to include trailer tongues, canopies, counters, etc. You will be notified of acceptance and pertinent information will be mailed to you.
