## RULES FOR "MISS TATER TOT" PAGEANT

- Participants will be divided into 2 classes of girls. Class A: Three (3) to Five (5) years of age by May 1, 2024. Class B: Six (6) to Eight (8) years of age by May 1, 2024. Proof of age must be provided (i.e., copy of birth certificate) with each entry form.
- Contestants are required to wear a suitable farmer-style or potato picking attire during the pageant.
- Contestants will be participating in a contest that will be held on the green at Mariners' Wharf Park. The Contest will be held in front of an audience where a selected panel of judges will determine the overall winners of the contest.
- Contestants will be judged on their neatness, poise, personality and their responses to simple interview questions.
- Completed entry forms must be received by May 13, 2024.
- Class A contestants will be required to arrive at Mariners' Wharf Park, South Water Street, no later than <u>9:45 am on May 18, 2024</u>; Class B will be required to arrive at Mariners' Wharf Park, South Water Street, no later than <u>10:15 am on May 18, 2024</u>.
